उत्तराखण्ड निजी विश्वविद्यालय अधिनियम, 2023 (उत्तराखण्ड अधिनियम संख्या 02 वर्ष 2024) की धारा 13 की उपधारा 1 और 2 के प्रावधानों के अनुसार राज्य कोटे के अंतर्गत प्रवेश पाने वाले 38 (25%) अभ्यर्थियों को उत्तराखण्ड के स्थायी निवासी होने का प्रमाण पत्र देकर शिक्षण शुल्क (Tuition Fee) में 25% की छूट प्रदान किये जाने के प्रावधान किये गये हैं। यह छूट प्रवेश की अंतिम तिथि के बाद और प्रवेश प्रक्रिया पूरी होने पर अभ्यर्थियों की योग्यता के अनुसार दी जायेगी।

अतः एम0बी0बी0एस0 पाठ्यक्रम हेतु 25 प्रतिशत सीटें (38 सीटें) उत्तराखण्ड के स्थाई निवासीयो तथा 75 प्रतिशत सीटें (112 सीटें ) अन्य अभ्यर्थियों को आवंटित करने की कृपा करें।

**Note: The 25% rebate in tuition fee will be given to 25% students (38 seats) after the last date of admission and on completion of the admission process. The excess amount deposited at the time of admission will be adjusted in the 2<sup>nd</sup> year fee.**

**First year fee to be paid in full at the time of admission. Fees from 2<sup>nd</sup> year onwards will be taken through Post Dated Cheques (PDC) in installments.**

**Note:**

(i) The candidate must complete his/her MBBS course in 4 ½ years. If he/she fails to do so, he/she shall pay ½ (half) amount of the tuition fee determined every 6 month as an additional tuition fee till he/she passes Final Prof. Part - II University Examination.

(ii) As per the Judgement passed by the Hon'ble Supreme Court of India, in the matter of Islamic Academy of Education and Another V/s State of Karnataka & Others (Writ Petition Civil No. 350 of 1993) in its judgement dated 14.08.2003, all candidates who obtain admission in the Shri Guru Ram Rai Institute of Medical & Health Sciences, Dehradun shall be required to submit an affidavit that he/she shall not withdraw his/her candidature after the last date of admission and under no circumstances tuition fee shall be refunded.

(iii) In case, the candidate withdraw his candidature after the last date of admission for any reason or unforeseen circumstances. The candidate/ guardian shall deposit full fees for 4½ years of the duration of the course. Fee once deposited will not be refunded in any circumstances.
