In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition against increased intake of MD(Community Medicine) qualification for 04 to 06 seats in respect of students being trained at Shri Guru Ram Rai Institute of Medical & Health Sciences, Dehradun under Shri Guru Ram Rai University, Dehradun, Uttarakhand**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the year 2022, upon which it shall have to be renewed.*
